# What you need to know

The Enbridge Ingleside Energy Center (EIEC) is host to multiple companies and their projects. There are several permits pending for the different companies operating at EIEC. These permits are in various stages of review, by state regulatory agencies and local municipalities.

To provide some clarity around these permits, we have listed them in the table below, along with their current status, purpose and next steps. These tables identify currently pending permits, not other permits that the respective companies will be seeking at the appropriate times in later stages of development
