**Exceptions to Kinder Morgan Crude & Condensate LLC’s Rules and Regulations Tariff**

Kinder Morgan Crude & Condensate LLC’s Texas Tariff No. 18, and supplements thereto and successive issues thereof, shall govern the portion of the transportation of the crude petroleum under this tariff on the Kinder Morgan Crude & Condensate LLC system with the following exception:

- Under Item 100.3, the deductions referenced in that section will be assessed by Kinder Morgan Crude & Condensate LLC at the connection between the Gray Oak Pipeline and the KMCC Pipeline instead of the Origin Points under this tariff.

**Exceptions to Gray Oak Pipeline, LLC’s Rules and Regulations Tariff**

Gray Oak Pipeline, LLC’s Texas Tariff No. [W] 1.5 ~~1-3~~, and supplements thereto and successive issues thereof, shall govern the portion of the transportation of the crude petroleum under this tariff on the Gray Oak Pipeline, LLC system with the following exception:

- Under Item 50, Shipper shall pay all charges and costs as provided for in this tariff or otherwise lawfully due to the Carrier relating to the transportation of the Shipper’s Crude Petroleum by the Carrier based on deliveries at the Destination instead of receipts at the Origin Point.
