## ENBRIDGE PIPELINES INC. 2017 Line 3 Replacement Project RAFFLE RULES AND REGULATIONS

By entering this Raffle, you acknowledge that you have read, understood, and agree to accept the Rules and Regulations of this Raffle as outlined below. You are not eligible to participate in this Raffle unless you choose to accept these Rules and Regulations.

### 1. How to Participate

The sponsor of this Raffle is Enbridge Pipelines Inc. ("Enbridge").

No Purchase Necessary

- 1.1 **The Raffle:** The Enbridge 2017 Line 3 Replacement Project Raffle (the "Raffle") is open to all qualifying residents of Canada that are of legal age of majority in the province in which they reside, excluding residents of Quebec, industry landowners and the Crown. The Raffle also excludes all employees (current and retired), directors, and representatives of Enbridge, its subsidiaries and affiliates.
- 1.2 **Qualifying Resident:** A qualifying resident is each landowner on title of the lands that is required to be personally served a Section 34(1)(a) Notice in accordance with the *National Energy Board Act* and an acknowledgement of receipt of that Section 34(1)(a) Notice has been obtained by Enbridge or its representatives in accordance with the following paragraphs:
  - (a) Each landowner that is successfully personally served their Section 34(1)(a) Notice(s) at a landowner meeting location held by Enbridge and acknowledges receipt of that Section 34(1)(a) Notice(s). The landowner meeting location will be held in the following locations during the Raffle Period:

- (i) Gretna
  - (ii) Morden
  - (iii) Bruxelles
  - (iv) Glenboro
  - (v) Souris
  - (vi) Maryfield
  - (vii) Kipling
  - (viii) Vibank
  - (ix) Bethune
  - (x) Loreburn
  - (xi) Rosetown
  - (xii) Kerrobert
  - (xiii) Provost
- (b) Each landowner that notifies Enbridge of his/her plan to be away from normal residence during the Raffle Period, as defined below, and therefore cannot attend one of the landowner meeting locations described above and makes themselves available in the out of province location to be successfully personally served with the Section 34(1)(a) Notice.

### 1.3 Raffle Period:

- (a) The Raffle Period for each landowner meeting location will start March 20, 2017 at 8:00 a.m. local time and will close March 25, 2017 at 8:00 pm, local time. To be eligible, entries must be received personally by Enbridge or its representatives no later than 8:00 pm local time, on March 25, 2017.
- (b) The Raffle Period for those landowners that qualify pursuant to Clause 1.2(b) will start March 20, 2017 at 8:00 am Mountain Daylight Time and close March 25, at 8:00 pm Mountain Daylight Time. To be eligible, notification of whereabouts must be done by phoning or

emailing Marnie Yohemas no later than 8:00 pm Mountain Daylight Time, on March 25, 2017.

- 1.4 **Raffle Entry:** Each qualifying resident, in accordance with Clause 1.2 above, will be entered into the Raffle.
- 1.5 **Raffle Entry Restrictions:** Each qualifying resident is restricted to one (1) entry and is only eligible to receive one (1) cash prize or one (1) patio set and (1) overall grand prize.

## 2. **Prize**

- 2.1 **The Draw:** Prize winners will be selected in the manner described in Clause 2.2 below. The draws for all prizes will be held on or before September 1, 2017. The eligible winner will be selected in a random manual drawing from all eligible entries received, in the presence of at least one witness.
- 2.2 **The Prizes:** There will be 53 prizes awarded in total: One (1) prize of \$3,000, one (1) prize of \$1,500, one (1) prize of \$500 and one (1) prize of a patio set for each of the 13 landowner meeting locations and one (1) overall grand prize of a truck (no greater than \$75,000 in value or alternatively \$75,000 Canadian in cash) drawn from all eligible entries. For those qualifying residents served in accordance with Clause 1.2(b), their entries will be included in the landowner meeting location nearest to their primary residence. The overall grand prize winner of the truck must accept the truck as is, or at the winner's election, choose a one-time payment of \$75,000 Canadian in lieu of the truck. Prizes must be accepted as awarded; no other alternatives, substitutions or transfers of the prizes will be allowed. Prizes do not include anything not explicitly set forth in the prize description(s) above. Each prize will be forwarded at the time the winner's signed Declaration, Waiver, and Release Form is received by Enbridge.
- 2.3 **Odds:** The odds of being selected to win a prize are solely dependent on the total number of eligible entries received at each landowner meeting location or in accordance with Clause 1.2(b) during the applicable Raffle Period.

## 3. **General Rules**

- 3.1 By participating in this Raffle, entrants agree to be bound by all Raffle Rules and Regulations. All winning entrants shall be subject to verification of eligibility under these Raffle Rules and Regulations.
- 3.2 All winning entrants must sign a Declaration and Release Form provided by Enbridge confirming understanding, acceptance, and compliance with these Raffle Rules and Regulations, acceptance of the prize as offered, and releasing Enbridge from any and all liability relating to the Raffle. All winning entrants must also correctly answer a time-limited, mathematical, skill-testing question, without mechanical aid or assistance

- 3.3 If a winning entrant is found to be ineligible, does not correctly answer the mathematical skill-testing question, is not otherwise in compliance with these Raffle Rules and Regulations, or declines to accept the prize, the prize will be forfeited and may be awarded to an alternate winning entrant at the sole discretion of Enbridge.
- 3.4 Entrants agree to be bound by the decisions of the Raffle judges, made in their sole discretion, regarding any aspect of this Raffle, including but not limited to eligibility requirements and interpretation of these Raffle Rules and Regulations, and such decisions shall be final, binding, and conclusive in all matters relating to this Raffle.
- 3.5 Entrants who enter the Raffle more than one (1) time are disqualified from the Raffle and all entries are automatically void.
- 3.6 This Raffle is subject to all Canadian federal, provincial and municipal laws. This Raffle is void where prohibited or otherwise restricted by law.
- 3.7 All entries become the property of Enbridge and will not be acknowledged or returned. Enbridge accepts no responsibility for lost, delayed, illegible, incomplete, misdirected, damaged, stolen, late, or destroyed entries. Enbridge may terminate or withdraw this contest at any time without prior notice.
- 3.8 By entering this Raffle, each winning entrant agrees and consents to the use of his/her name, city of residence, and image in any publicity carried out by Enbridge, without compensation.
- 3.9 Enbridge shall not be responsible in any way for the use of, or bear any liability whatsoever in any way attributable to, the prize(s) awarded in this Raffle or the events forming part of this Raffle. By entering this Raffle or by accepting any prize, entrants release and hold harmless Enbridge and its subsidiaries, affiliates, officers, directors, employees, representatives and agencies from any and all liability or any injuries, accidents, loss, misfortune, or damages to person or property of any kind arising from or relating to conduct of or participation in this Raffle, awarding of a prize, or acceptance, possession, use, enjoyment, misuse or nonuse of any prize or parts thereof, and from liability to any other persons relating to or resulting from entering this Raffle.
