Currently they are doing weed control starting from kick off and they were at road 14 of 75 as of Saturday. Fencing is still currently ongoing and they are on road 63 there are only a few more fences to build and they will be moving onto spread four.

Valves number 10 and 13 were completed along with backfilling. Valve 11 is currently being worked on and 12 is still currently awaiting backfilling.
