Additional Observations and Summary of Activities or Concerns

Attended daily safety meetings and discussed daily scopes each morning with the Contractor Liaison, and/or the Senior Construction Monitor.

Weekly activities included spot-checking km 39 and 40.

The week's activities consisted of orientation and introductions for the new Aboriginal Construction Monitors for Spread 2: Ashley Swiftwolfe, Don Nights, and Drayton Kasokeo.

The crew underwent a variety of safety and environmental orientation meetings on November 8. They met with: O.J Safety, Enbridge, Matrix Solutions Inc., Mel Abraham from Spread 1, land representatives, and safety representatives. The crew also sat in a meeting with Poundmaker First Nation.

On November 9, the crew met with Brennon P for a biosecurity meeting and were given alignment maps for the wash station. Senior Aboriginal Monitor (Spread 1) Virgil Deschamps mentored the crew; later, they shadowed Spread 1 monitors. Lastly, the crew underwent computer and software training with Matrix.

November 10, weather warnings were in effect for Provost. The crew worked on daily reports with the help of Spread 1 ACM monitors. A group meeting was held with Dean Pooyak, Ashley Swiftwolfe, Don Knight, and Drayton Kasokeo to discuss monitoring locations. Later they travelled to Spread 2 kick off. They became affiliated with the area and devised a monitoring plan for water source, agricultural lands, wildlife, and live habitats.
