Additional Observations and Summary of Activities or Concerns

Back on spread 5, the beginning of the week kicked off with the spray program meeting for spread 5/6 in White city. Focus Industrial Vegetation Management (Focus) was the spray company working on the project and handed out ERP's, MSDS and went over safety concerns throughout the meeting. Focus spray crews require a start time of 4:00am; because wind levels are not very high at this time – wind is a main factor in spraying.

Spray program started off at SSKP528+000 (kick off or KO), the crew utilized side by sides equipment with extensions to spray from the side of the vehicle and hand hoses for areas where the side by sides could not access. The wind level throughout the week was very high and spray progress was made up to SF4 SSKP535+000, they conducted wind level testing with a hand-held reader and spray test by hand – which all failed.

The next week will pick up at SF4 and make way east on right of way and kick off for clean up on spread 5 will be on Friday June 14th in White City.
