

**Westcoast Energy Limited Partnership  
Sunrise Expansion Program

On April 27, 2026, the Commission of the Canada Energy Regulator issued Certificate GC-135 under Section 186 of the Canadian Energy Regulator Act authorizing the construction and operation of the Westcoast Sunrise Expansion Program ([C39063-3](#)). Upon the issuance of the certificate, the exemptions granted under Order XG-002-2026 also came into force ([C38107-3](#) and [C38914-3](#)).
