This letter confirms the support of the Canadian Association of Petroleum Producers (CAPP) for the Competitive Toll Settlement and the application to be submitted by Enbridge to the National Energy Board (“NEB”).

CAPP support for the CTS is subject to Enbridge filing revised Line 9 Settlement Agreements Application with the NEB which removes all references to the transfer or roll in of the Line 9 rate base into the Enbridge Mainline rate base.

CAPP acknowledges that the Canadian agreements between Enbridge and CAPP included in Schedule H of the CTS will be superseded for the duration of the CTS. Upon expiry or termination of the CTS, any of the Canadian agreements that have not expired will come back into effect as of the date of expiry or termination of the CTS. The assets under the Canadian agreements will be included in the Canadian Mainline at their remaining undepreciated costs.

CAPP believes the CTS continues the foundation of the cooperative working relationship between Enbridge and its shippers and producers established by previous Incentive Toll Settlements. The CTS provides toll certainty for all shippers on the Enbridge pipeline system and a simplified toll and tariff structure.
