Re: Enbridge Pipelines Inc.

Competitive Toll Settlement and Final Toll Application

Enclosed for filing with the National Energy Board ("NEB" or "Board"), is the Application of Enbridge Pipelines Inc. ("Enbridge") for approval of the Competitive Toll Settlement ("CTS") for tolls on the Canadian Mainline for the period of July 1, 2011 to June 30, 2021. The Application also seeks approval of final tolls for 2010 and 2011 on the Canadian Mainline and seeks various other related approvals and relief.

The CTS negotiations were conducted in accordance with the Board's *Revised Guidelines* for *Negotiated Settlements of Traffic, Tolls and Tariffs*. The Application outlines the CTS negotiation process and the support obtained for its implementation and approval by the Board. Enbridge is not aware of any concerns or objections with respect to the CTS and believes that all parties having an interest in the Enbridge's traffic, tolls and tariffs were afforded a fair opportunity to participate and have their interests recognized and appropriately weighed during the course of CTS negotiations. Enbridge submits that the tolls that would result from the approval of the CTS as well as the final tolls requested in the Application are just and reasonable and not unjustly discriminatory.

By letter dated April 11, 2001 (File 4200-E101-2 & 4775-E101) the Board requested that in future toll filings, Enbridge "advise parties that they may file comments with the Board within ten calendar days from the date of the application". As permitted by the Board's letter, interested parties are advised that they may file comments within ten (10) calendar days of this application.

In making this filing with the Board, Enbridge is concurrently providing notice of the filing to: (i) all shippers on the Enbridge Mainline; (ii) all Enbridge Mainline tariff subscribers; and (iii) parties to RH-2-2010.
