- ~~1. **CONTRACT VOLUME** — The term rates apply only to the Contract Volume specified by Shipper in Appendix A of the TSA but do not apply to volumes Tendered in excess of the Contract Volume amounts specified by Shipper in Appendix A of the TSA.~~
- ~~2. **MONTHLY NOMINATIONS** — Express Pipeline Ltd. will receive Nominations on behalf of Express Pipeline LLC and Platte Pipe Line Company, LLC under the conditions set forth in Item 6 of its Rules and Regulations.~~
- ~~3. **APPLICATION OF RATES** — This tariff applies only to volumes physically Tendered by Shipper at Hardisty, Alberta and delivered at the International Boundary near Wild Horse, Alberta, Canada. Shipments directed to delivery points on Express Pipeline LLC and Platte Pipe Line Company as set forth in Note 2 will be subject to the applicable FERC uncommitted tariff applying from the International Boundary to the specified downstream delivery point.~~
- ~~4. **DEFICIENCY PAYMENTS** — Shipments directed to a delivery point on Platte Pipe Line Company, LLC or Express Pipeline LLC will be subject to the Platte and/or Express Rules and Regulations governing Prorationing. Term Shippers will not be relieved of their Deficiency Payment obligations pursuant to the TSA as a result of the Term Shipper's failure to obtain capacity on Express and/or Platte.~~
- ~~5. **PETROLEUM** — Petroleum includes all of the types of petroleum as defined in Item 7.3 of Express Pipeline Ltd.'s Rules and Regulations.~~
- ~~6. **ABANDONMENT FUND SURCHARGE** — There shall be a surcharge on each of the rates of \$U.S. 0.0711/m³.~~

EXCEPTIONS:

- ~~1. **Exception to Express Pipeline Ltd.'s Rules and Regulations, Item 6.6, Term Shipper Nominations:** To the extent a Shipper Tenders a volume of Petroleum less than the Monthly Volume, Shipper shall pay to the Carrier an amount equal to the difference between the sum of (i) the product of the volume Tendered and the Term Rate and (ii) the product of the volume equal to the difference between the Monthly Volume and the volume utilized in~~

~~(i) above and the Term Rate for light petroleum deliveries at the Delivery Point as defined in the TSA.~~

~~2. **Exception to Express Pipeline Ltd.'s Rules and Regulations, Item 6.7, Term Shipper Make-Up Rights:** For the purposes of this tariff, Item 6.7 is not applicable.~~
