The tolls within this Tariff are payable in U.S. dollars.

---

The tolls of the Carrier are regulated by the CER on a complaint basis. The Carrier is required to make copies of the Tariff and supporting financial information readily available to interested persons. Persons who cannot resolve traffic, toll and tariff issues with the Carrier may file a complaint with the CER. In the absence of a complaint, the CER does not normally undertake a detailed examination of the Carrier's tolls.

**NOTES:**

**1. PETROLEUM CLASSIFICATION:**

Petroleum shall be classified by Carrier on the basis of the measured density and viscosity at the time of Tender. When the density of the Petroleum falls within the density range of one classification and the viscosity falls within the viscosity range of another classification, the Petroleum will be deemed to be in the classification with the higher charge. Surcharges will be calculated as a percentage of the Light Petroleum charge. See Rule 7 of the Rules and Regulations contained in CER No. [W] 182 174.

**2. ABANDONMENT SURCHARGE:**

There is a surcharge on each of the tolls from Hardisty, Alberta to the International Boundary near Wild Horse, Alberta of [U] \$US 0.1274/m<sup>3</sup>.
