In the absence of a complaint, the CER does not normally undertake a detailed examination of Enbridge Bakken Pipeline Company Inc.'s tolls.

NOTES:

- Abandonment Surcharge:** In addition to the tolls listed above, an abandonment surcharge is applicable to the uncommitted and the committed tolls of \$USD 0.1013/bbl, pursuant to the NEB MH-001-2013 Reasons for Decision and the CER's Five-Year Review of Abandonment Cost Estimates and Set-Aside and Collection Mechanisms 2021 proceeding. The Abandonment Surcharge is subject to periodic review, adjustment and approval by the CER.

2. **Escalator:** Commencing July 1, 2025, the committed toll shall be increased annually as of July 1 each year by three percent (3.0%).
3. **Volume:** The Committed Toll Applies to Committed volumes specified in Schedule A of the TSA but does not apply to volumes Tendered by shipper in excess of their contract.
